DECISION

Acting at the request of Baltic Gas spółka z ograniczoną odpowiedzialnością i wspólnicy spółka komandytowa, based on Article 113 § 1 of the Code of Administrative Procedure

I hereby decide

to correct an obvious typographical error in the decision of March 13, 2013, ref. no. DGKw-4771/27/10135/13/AS, issued for the benefit of Baltic Gas spółka z ograniczoną odpowiedzialnością i wspólnicy spółka komandytowa and transferring, upon consent of LOTOS Petrobaltic S.A., to Baltic Gas Sp.z.o.o. i wspólnicy spółka komandytowa with its registered office in Gdańsk, license no. 6/2007, of May 11, 2007, for the production of gasoline natural gas from "B4" deposit located in the area of the Polish exclusive economic zone of the Baltic Sea, by replacing in the decision the text reading "Baltic Gas Spółka z ograniczoną odpowiedzialnością i wspólnicy spółka komandytowa with its registered office in Warsaw" with "Baltic Gas Spółka z ograniczoną odpowiedzialnością i wspólnicy spółka komandytowa with its registered office in Gdańsk"

Justification

By the decision of March 13, 2013, ref. no. DGKw-4771/27/10135/13/AS, the Minister of Environment transferred, upon consent of LOTOS Petrobaltic S.A., to Baltic Gas Sp. z.o.o. i wspólnicy spółka komandytowa with its registered office in Gdańsk, license no. 6/2007, of May 11, 2007, for the production of gasoline natural gas from "B4" deposit located in the area of the Polish exclusive economic zone of the Baltic Sea.

As a result of an obvious typographical error in the introduction and justification of the decision, the registered office of the applicant was incorrectly specified - "Warsaw" instead of "Gdańsk".

The case files of the procedure clearly indicate that the case refers to the entity entered in the register of entrepreneurs of the National Court Register under no. 0000440043 Baltic Gas spółka z ograniczoną odpowiedzialnością i wspólnicy spółka komandytowa with its registered office in Gdańsk.

Therefore, it should be decided as above.

The party may apply to the Minister of Environment, within 7 days from the decision delivery date, for re-examination of the case.
